Written procedure No.01, initiated 06.01.2023

1. Description:

The Written procedure for approval of modification of the Interreg – IPA CBC Bulgaria – Serbia Programme 2014-2020, was initiated by the Head of the Managing Authority and co-chair of the Monitoring Committee (MC) on 06.01.2023.

The modification of the Interreg – IPA CBC Bulgaria – Serbia Programme 2014-2020 is related to already approved decision from 04.03.2021 of the Joint Monitoring Committee for non-substantial amendment of the financing plan of the Programme document in compliance with the provisions of Article 31, paragraph 5A of the Implementing Regulation (EU) No 447/2014 (transfer of 66 248 EUR from Priority Axis 2 "Youths" to Priority Axis 1 "Sustainable tourism" and transfer of 30 420 EUR from Priority Axis 2 "Youths" to Priority Axis 3 "Environment"), as well as further instructions of the European Commission (EC) the above amendment to be reflected in other relevant parts of the Programme document and accepted by decision of the EC not later than 31.12.2023.

The official letter No. 99-00-2-2/06.01.2023 with the proposed amendment, was sent to the MC members via e-mail, for review and approval.

The MC members were given 10 working days to send their approval or comments on the proposed documents. Only opinions of approval were received.

2. Decisions:

Decision 1:

The MC approves the modification of the Interreg – IPA CBC Bulgaria – Serbia Programme 2014-2020 with reflected amendments of the programme document in compliance with the already made change in the financial plan of the Programme.

The hereby decision enter into force on 21th January 2023 – the date following the deadline for submission of comments from the MC.
